




- ii) That the lessee shall pay all taxes, levies and rates except land tax payable or hereafter become payable in respect of the said land or any buildings or structures put up thereon by the Lessee.

- iv) That the Lessee shall not use or permit to use the said lands for any purpose otherthan the purpose mentioned above.




